### **Next Steps Following PC Recommendation**


- I. UGM Committee reviews all UGA expansion proposals and provides a separate recommendation to the BoCC
- 2. BoCC review and public hearing before decision



# COMPREHENSIVE PLAN GOALS & OBJECTIVES

# **Land Use Chapter**

- Encourage residential development that is compatible with the surrounding environment.
- Accommodate projected growth in a way that ensures varied and affordable housing.

# **Housing Chapter**

- Reduce barriers to affordable housing.
- Ensure adequate housing opportunities.
- A variety of housing types should be available to meet the changing needs and demographics of the community.
- Support efforts to preserve, maintain, rehabilitate, and expand the supply of affordable housing.

### Goal I

### CHANGES TO DRAFT

# Goal I

- Action 1. Prioritize infill in areas that create the least amount of displacement.
- **Action 2.** Consider the impacts of zoning amendments and regularly evaluate zoning within the UGA.
- **Action 3.** Ensure outreach includes underrepresented community members, especially related to changes that may impact housing.
- **Action 4.** Consider further evaluation of Grand Mound housing needs in collaboration with the County Comprehensive Plan.
