## #1 - Uniting for Green Change: An Eagle Scout and IvyBeGone Team Tackle Invasive Ivy at Burfoot Park



In Thurston County, a collaborative effort between an Eagle Scout and the IvyBeGone team is tackling the invasive English ivy at Burfoot Park. What started as an initiative with the Boston Harbor Association has led to significant environmental improvements, including clearing an acre of land and saving fifty trees. Supported by Thurston County Parks and Trails, this partnership exemplifies community-driven environmental conservation, inviting locals to join in the efforts to preserve and restore the park's natural beauty.

## #2 - Warning! Jury Scam in Thurston County



Be aware! Individuals are calling citizens and stating they missed jury duty, and a warrant has now been issued. The callers are identifying themselves as Thurston County Sheriff Deputy and have the citizen's name, address, and phone number. The caller is providing a number they claim is associated with the missed jury service. Name, address, and phone numbers are available via public records not associated with jury duty. The numbers being provided are not associated with the court's official jury management system.

These callers are not court staff or from the Sheriff's Office. Court staff will never ask potential jurors for money or confidential information like Social Security numbers, birth dates, or bank account information over the phone, email, or mail. If you receive a phone call, hang up, and put away your wallet. Anyone who responded to these scams should report the incident to the police.
